Pursuant to Sec. 10-251 of the Union Grove Municipal Code, a license is required to permit or allow any room used for the purpose of a dancehall in the village. To apply for a Dance Hall License, submit this application with the license fee and any necessary attachments listed below. Application materials are accepted by mail, in the Municipal Center drop-box or in-person at the Municipal Center during normal business hours (Monday-Friday, 8 a.m. to 4:30 p.m.). Contact the Village Offices for questions at (262) 878-1818.

License Classification: Fee \$25.00

- Class A License:** premises in which a public dance is held where a charge is made for admission or where admission is by means of the purchase, possession or presentation of a ticket where the dance is advertised as such and where an orchestra es employed to furnish dance music.
- Class B License:** premises in which a public dance is held and where no charge is made for admission and where an orchestra is employed to furnish the dance music.
- Class C License:** dancing is incidental to such other business conducted in the premises used for dancing and where no charge, directly or indirectly, is made for admission and no orchestra or musicians are employed to furnish music for dancing.
- Special Permit License:** Not more than two public dances annually in any structure or premises and valid only within a specified 24-hour period.
- Any other attachments required by Sec. 10-255 or requested by the Village Clerk.
